his heirs and assigns. It is upon this condition (and this instru-  
ment of writing is taken for and considered as a lien upon said  
timber) that when the said Hodgkins shall be fully reim-  
bursed for any and all advances made by him then the said Spars  
to revert to the said Satcher and the title to the same to revert in  
the same S.P. Satcher the same as if this instrument of writing
