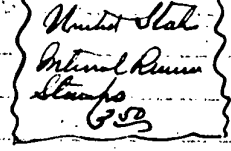
The State of Florida } Thomas J. John W. Putter as Sheriff of said County  
Santa Rosa County } by virtue of an execution issued from the Circuit  
Court of said County upon a Judgment rendered at the Spring Term  
of said County to wit: on the 15<sup>th</sup> day of June 1867 wherein Richard  
Thackery and Pally Thackery are Plaintiffs and E. A. Pearce surviving  
partner of the firm of E. A. Pearce & Son are defendants for the sum  
of Two thousand seven hundred and forty six <sup>25</sup>/<sub>100</sub> Dollars besides  
costs which Execution was levied on the following property to wit:  
Lot No one (1) of fractional section Twenty five (25) in Township one  
north of Range Twenty eight West containing Seventy five acres  
together with the Steam Saw Mill hereditaments and appurtenances  
thereunto belonging and better known as "Pearce Mills" in said County  
the same being the mortgaged property the mortgage foreclosed and  
Judgment for the amount due on the same - levied on as the  
property of the defendant on the 15<sup>th</sup> day of November 1868.

And whereas said sale was duly advertised for the space of  
30 days according to law. I as said Sheriff proceeded to sell  
to the highest bidder before the Court House in Milton on the  
1<sup>st</sup> Monday in March 1870 the said property herein described  
and at said sale S. B. Paine and R. K. Sigon were the highest  
and best bidder at & for the sum of three thousand five hundred  
dollars.

Now for and in consideration of the said sum  
of three thousand five hundred Dollars to me in hand paid by the  
said S. B. Paine and R. K. Sigon the receipt whereof I hereby acknow-  
ledge I as said Sheriff hereby sell and convey unto the said  
S. B. Paine & R. K. Sigon all the right title and interest which  
the said defendants had in and to said described premises  
to have and to hold the same to the use & behoof of the said S. B.  
Paine & R. K. Sigon their heirs and assigns forever.
