 County setting as a Court of Chancery in the following words and figures to wit:
 To the Honorable Judge of the District Judicial Circuit of the State of Florida sitting
 as Chancellor for the County of Santa Rosa Will for revision in Chancery
 Your orator Marshall & Snowden humbly Complaining sheweth unto your honor that
 on the fifteenth day of March in the year of our Lord One thousand eight hundred
 and fifty seven your orator made executed and delivered unto George A. Snowden
 of the State of Alabama a Deed of Trust to certain lots of ground situated within the town
 of Milton and to be held by the said George A. Snowden to the use of your orator
 two Infant Sons and Infant daughter to wit: Henry A. Snowden William C. Snowden
 and Mary F. Snowden. The said Lots are described in the plan of said town
 as follows Lot Number (4) form in Block Number twenty containing fifty feet
 front on Milling Street and running back sixty feet making said Lot fifty
 feet front by sixty feet deep also Lots Number one (1) and three in Block Num-
 ber twelve (12) Commencing at the Corner of Perry Hill Street and Concord
 Street running North on the line of Concord Street two hundred and forty feet (200)
 to the Corner of Concord and Monroe Street thence east on a line with Monroe
 Street one hundred feet (100) thence south to Perry Hill Street two hundred
 and fifty two feet and five inches (262 $\frac{5}{8}$) thence on a line with Perry Hill
 Street one hundred feet to the place of starting and your orator conveyed
 at the same time and in same deed Deed of Trust to the use of aforesaid the
 following named Negroes slaves to wit Henry a woman and Charles
 a man and known a Boy and Jane a girl and Mary a girl all which
 will more fully appear unto your honor by reference to the said Deed of
 Trust which is hereto annexed And your orator sheweth unto
 your honor that at the time of the making executing and delivery
 of the said Deed of Trust unto the said George A. Snowden and
 before the said Deed was drawn your orator advised the attorney
 who drew the deed of Trust aforesaid to reserve in the latter clause
 of said Deed unto your orator the right for and during his natural
 life to have use Exercise Control Exchange bargain sell and
 make lawful titles and Deeds of Conveyance to all or any part
 of said property mentioned in said Deed of Trust for the benefit
 of the said Henry A. William C. and Mary F. Snowdens
 And now in tender consideration thereof and for as much
 as your orator is remediless in the premises and by the
 direct and strict rules of Common Law and courts have
 adequate relief save in a Court of Equity where matters
 of this and the like nature properly Cognizable and relievable.
 Your orator therefore prays that your honor may grant order
 and decree that the said Deed of Trust be as revised altered
 reformed and amended in the last clause of said Deed
 after the words Exercise and Control so as to read Have
 use exercise Control exchange bargain sell and make
 lawful titles and Deeds of Conveyance to all or any part of
 said property real or personal for the sole use and benefit
 of the said Henry A. Snowden William C. Snowden and
 Mary F. Snowden &c And your orator prays that
 your honor will grant unto orator the States most gracious
