This Deed of Conveyance made and entered into this
Fifteenth day of February in the Year of our Lord One thousand
and Eight hundred and Seventy two between George P Perreot
and his wife Mary Perreot of Rockport in Brazos County
and State of Texas of the first part and John Chain W. H. Chamberlain
W. H. Stokes Junior Warden Trustees of Santakasa Lodge No. 16. of Free and
Accepted Masons located and situated in the Town of Milton in
the County of Santa Rosa and State of Florida of the second
part Witnesseth that whereas the said Mary Perreot having
separate and independent title to the property or premises hereinafter
to be particularly mentioned and described and her said hus-
band having joined her in the sale of the same to the said
party of the second part in trust for the use and benefit of said
Lodge and wishing to convey the title thereof to the said party
of the second part in trust for the use of said Lodge and
their successors and assigns forever they the said party of the
first part join in this deed of Conveyance for that
purpose - Therefore the said party of the first part for and
in consideration of the sum of Two hundred dollars of good
and lawfull money of the United States of America to them
in hand paid by the said party of the second part, the receipt
whereof is hereby acknowledged and Confessed, have bargained
granted sold enfeoffed Conveyed and Confirmed, and by
these presents do bargain grant sell enfeoff Convey and Confirm
unto the said party of the second part as trustees of said
Lodge and their successors (Trustees in trust for the use and benefit
of said Santakasa Lodge No 16,) a certain piece of land situate lying
and being in the County of Santa Rosa and State of Florida and within
the Corporation of the town of Milton known and distinguished
on a plot of lots surveyed and laid off by John W. Chamberlain
then County surveyor, on the North half of Lot number (3) three
of fractional Section Number (3) three in Township One North of
Range Twenty eight West, as the whole of Lot Number
(4) Four or "E" Robison lot, and also that part of ground
lying broadside of said Lot No. 4, West up to the lot own-
ed by Mrs Prigs - Containing in all about one acre
and one fourth of an acre more or less Together with
all and singular the hereditaments and appurtenances there-
unto belonging or in any wise appertaining and the
reversion and reversions remainder and remainders
rents issues and profits thereof and also all the Estate
right title interest claim or demand whatsoever of the
