This Indenture made and entered into the twenty second day of July A.D. 1871 by and between Robert C. Caldwell as surviving trustee of Sarah E. Humphreys the said Sarah E. Humphreys and her husband Frederic C. Humphreys parties of the first part; and Peter Knorob and George Mainward of the second part. Witnesseth that the said parties of the first part for and in consideration of the sum of twelve hundred dollars to them in hand paid the receipt whereof is hereby acknowledged have granted bargained sold and conveyed and by these presents do grant bargain sell and convey unto the said parties of the second part and to their heirs and assigns forever the following described pieces parcels or tracts of land situated lying and being in the Counties of Escambia and Santa Rosa State of Florida and designated in the general land office at Washington City as follows: the south East quarter of the South East quarter of Section No. five (5) in Township No five (5) Range No thirty (30) North and west containing thirty nine and sixteenths (39 <sup>16</sup>/<sub>100</sub>) acres in Escambia County. The south half of lot No four (4) and lot No five (5) and south half of lot No two (2) and lot No one (1) of section nine (9) in township No five (5) of Range No thirty (30) North and west containing two hundred and eighty one seventy three hundredths (281 <sup>73</sup>/<sub>100</sub>) acres in Escambia County. Lot No one (1) of section No ten (10) in Township No five (5) of Range thirty (30) North and west containing one hundred and fifty four (154) acres in Santa Rosa County. Lot No two (2) in section No ten (10) in township No five (5) of Range No thirty (30) North and west containing one hundred and seventy one thirty five hundredths (171 <sup>35</sup>/<sub>100</sub>) acres in Santa Rosa County. The North East quarter of the North East quarter of Section No Eight (8) and lot No four (4) of section No four (4) in township No five (5) of Range No thirty North and west containing one hundred and ninety seven seventy one hundredths (197 <sup>71</sup>/<sub>100</sub>) acres in Escambia County. The North west quarter of the North East quarter of Section No Eight (8) in township No five (5) of Range No thirty North and west containing thirty nine and eighty eight hundredths (39 <sup>88</sup>/<sub>100</sub>) acres in Escambia County. And the north half of Lots No two (2) and three (3) in section No nine (9) township No five (5) of Range No thirty (30) North and west containing seventy nine (79) acres more or less according to the United States survey and being in Escambia County. Together with all and singular the hereditaments and appurtenances thereto belonging or in any wise appertaining to have and to hold the said premises above particularly mentioned and described unto the said parties of the second part and their heirs and assigns forever.
