Referee's Deed

Thomas the Circuit Court for the County of Escambia State of Florida in an action wherein Ezekiel E. Simpson and Prudence Wright as Executors of the last will and testament of Joseph Pinyth deceased were Plaintiffs and the Alabama & Florida Rail Road Company mortgagee and the Pensacola & Mobile Rail Road Manufacturing Company & A. C. Plouffe as trustee and William Wallace and Edwin Hoyt Stehewich Knight & Frederic Ayers and William West Hadden Coombs & Samuel G. Jones comprising the firm of W. F. West & Co. and R. A. Stearns assigned of mortgagee equity of redemption were defendants On the 28th day of March 1872 rendered a judgment for closing and having the said defendants and all persons claiming by, through or under them or any or either of them of all right, title interest and equity of redemption in the following described lands situated in the said County of Escambia and in the County of Santa Rosa in the said State of Florida and known and described in United States survey as follows to-wit:
