This agreement made and entered into this 21<sup>st</sup> day of October  
 1872 Between Henry May and Martin H Sellers. Witness  
 That the said May has this day sold to the said Sellers one  
 undivided half interest in the following property to wit: Ten  
 cords of green four log Cuts now being used by said May  
 at his Log Camp also one undivided half interest in all  
 the Camp appliances and fixtures and Stock hogs. It being  
 the interest and of said party that said Sellers is to become  
 by his said purchase an equal partner with said May in his  
 said business of getting logs and to conduct the business together  
 for the sum of four hundred and twenty five dollars to be paid as  
 follows by the said May and Sellers by Martin H Sellers of our  
 man made for the sum of four hundred and seventy five dollars  
 which shall be taken and considered as a payment of one half  
 of that amount to wit: Eighty seven & 7/10 dollars by the said Sellers  
 to the said May on the nine hundred and twenty five dollar pur-  
 chase money of said half interest in said Camps and the  
 said Sellers is to make and deliver to said May his promissory  
 note for the sum of Eight hundred and thirty seven & 7/10 dollars  
 due and demanding interest from the 15<sup>th</sup> day of October 1872  
 which, notwithstanding this instrument is dated the 21<sup>st</sup> of  
 October 1872 shall be taken and considered as the day when  
 the property herein sold passed and said partnership com-  
 menced. And it is understood and agreed that this instru-  
 ment shall be considered and taken as a mortgage from said  
 Sellers to said May of the property herein sold by said May  
 to said Sellers to secure the payment of said note. And it  
 is further understood that in case either party here to become  
 dissatisfied and desires to sell his interest in the partnership  
 assets that he shall give the other party here to the refusal of  
 buying said interest. In witness whereof we have
