 dollars lawful money of the United States to each and every one  
 of us in hand paid by M V B Jordan the receipt whereof  
 is hereby acknowledged have given granted bargained and  
 sold and by these presents do give grant bargain and sell  
 unto the said M V B Jordan his heirs and assigns forever  
 all and whatsoever right title and interest we possess in  
 to and for the following described lots parcels or pieces of  
 land To wit: Lot sixty five (65) in Block (4) four in the  
 plain of the lands of James Quinn (deceased) in Santa Rosa  
 County State of Florida also the following described parcel  
 of land in the town of Milton County of Santa Rosa begin-  
 ing at the north west corner of an acre of land sold and  
 conveyed by George Walker to P. A. Ball said acre of land  
 sold to said Ball being located in the north east corner of  
 the south half of lot five section three Township one Range  
 twenty eight (28) north and west in County of Santa Rosa then  
 due west Two hundred and ten feet to a stake, thence due  
 east Two hundred and ten feet to the beginning corner in  
 that acre of land which is due west of and adjoining  
 on acre sold by George Walker to P. A. Ball being the north  
 east corner of said described lot of land purchased by  
 George Walker of the United States which was conveyed by  
 George Walker to Susan S Peloh by deed dated 19<sup>th</sup> of March  
 AD 1847 also lots number five six seven eight nine  
 eleven twelve thirteen and fourteen each lot to contain
