Mitchell and unto his heirs and assigns the following described real estate situate in Santa Rosa County State of Florida To wit a certain tract of Land in said County and known as Section (16) Sixteen Township two (2) North Range Thirty (30) West and the South East 1/4 and West 1/2 of North East 1/4 and East 1/2 of North West 1/4 and East 1/2 of South West 1/4 of Section one (1) Township two (2) North Range Thirty (30) West whereon is erected a Steam saw mill and other improvements containing in all about 1040 acres together with all and singular said saw mill and other improvements.
