 between W A Benbow Sheriff of said
 County of the first part and Francis Janga of the same
 place of the second part. Witnesseth that Whereas a certain
 writ of Fieri Facias in favor of Monday ^{then rights of his wife} Allen ^{deceased}
 and Margaret Allen Administrators of Estate of William
 Mitchell Deceased and against J W Darr and Francis Janga
 was issued from the Clerks Office of the Circuit Court for
 said County which said writ of Fieri Facias was levied by the
 party of the first part upon the following described real Estate
 lying and being situate in the State and County aforesaid
 to wit Lot No (3) Three Section (14) Tenth Township (1) one
 North Range (28) Twenty Eight West Containing 13 1/2⁰⁰ Acres
 also part of Lot No (2) Two Fractional Section (14) Tenth
 Township (1) one North Range (28) Twenty Eight West. That
 is to say all that part of that fractional section South of the
 line commencing at the Water and running parallel
 with the northern line of a Garden Fence of Ebon Darr
 until it strikes Section (13) Fifteen which part of said Lot
 contains (20 1/2) Twenty and one half Acres and ever served
 upon as the property of the said J W Darr, which said Property
 after being advertised according to Law was upon the first
 Monday in June 1877 exposed to public sale before the
 Court House door in the Town of Milton during the usual
 hours of sale and was bought by the party of the second part
 at and for the sum of Seven Hundred and Eight Dollars and
 forty five Cents \$708 45/100 he being the highest and best
 bidder. Now ye that the said party of the first part for
 and in consideration of the sum of Seven Hundred and
 Eight 45/100 to him in hand paid by the party of the second
 part at and before the execution and delivery of these presents
 have bargained granted sold and conveyed and by these
 presents doth grant bargain sell and convey unto the
 said party of the second his heirs and assigns all the right
 title interest Claim or demand whatsoever of the said
 J W Darr in and to the lands above particularly mentioned
 and described together with the improvements thereon. To
 have and to hold unto the said party of the second part
 his heirs or assigns the above described premises the same
 as the said J W Darr might or could have done
