No 5. Is that portion which embraces as follows viz

Commencing on Pond Creek at Township line dividing 288 North thence up Pond Creek to its head thence East to the Pollard Road leading from Milton Pollard thence up said Road to Township line dividing 485 North thence East along said line to West Cold Water thence up said Creek to the Alabama line thence along said line to Big Juniper Creek thence down said Creek to the Red Rock Bridge across Juniper Creek thence from said Bridge by the Wagon Road to the Bridge across Cold Water thence down said Creek to Township line dividing 243 North thence West along said line to Pond Creek. And the voting place to be at Milligan old Mill

No 6. Is that portion which embraces as follows viz

Commencing at the Mouth of Dead Fall Creek on Yellow River thence up said Creek to its head thence due West to the head of narrow Creek thence down said Creek to Black Water River thence up said River to the Alabama line thence along said line to the line of Walton County thence down said line to the Mouth of Dead Fall Creek, and the voting place to be at David Stewart

No 7. Is that portion which embraces as follows viz

Commencing at the Mouth of Cold Water Creek thence up said Creek to the Bridge known as the Fleming Bridge thence along the Wagon Road to Red Rock Bridge across Juniper Creek thence up Big Juniper Creek to the Alabama line to Black Water River thence down said River to the Mouth of Cold Water Creek and the voting place to be at James & Flemings

No 8. Is that portion which embraces as follows viz

Commencing at the Mouth of Shoar River thence up said River to the Walton County line thence up said line to Yellow River thence up said River to the Mouth of Deadfall Creek thence West across to the head of narrow Creek thence down said Creek to where it empties into Black Water River to the Mouth of Bone head Creek thence up said Creek to its head thence due East to the head of Baggett's Creek thence down said Creek to where it empties into Yellow River thence down said River to the Mouth of Shoar River and the voting place to be at Mansford Griffiths

No 9. Is that portion which embraces as follows viz

Commencing on Yellow River where range land dividing 268 27 crosses Yellow River and thence up said River to the Township line dividing 182 North thence along said line to Shoar River thence down said River to Yellow River thence up said River to the Mouth of Baggett Creek thence up said Creek to its head thence due West to the head of Bone head Creek thence down said Creek to Black Water River thence down said River to the Range line dividing 268 27 thence south along said Range line to Yellow River and the voting place to be at Blacks Mills
