Agreement

J Lunderhauer & Co  
M C Stokes

This agreement made and entered into this 1<sup>st</sup> Day of August 1878  
by and between M C Stokes of Santa Rosa County and J Lunderhauer  
& Co of Milton Fla. Manufacture that the said M C Stokes do hereby  
sell and agree to deliver to the said J Lunderhauer & Co at Wright  
Broom at Milton Florida, by or before the 1<sup>st</sup> Day of March 1879 the  
following priced prime saw timber to say: (1000) One thousand  
pieces saw timber at the market rate when delivered averaging  
(30) thirty feet & upwards and Classing 121 or better. J Lunderhauer  
& Co hereby agree to advance to the said M C Stokes Supplies to be  
furnished from time to time as required, to Manufacture and  
haul said timber & raft it to market. Any balance due upon  
timber delivered after payment of advances shall be paid  
to the present indebtedness due by said M C Stokes to  
J Lunderhauer & Co and the said M C Stokes hereby gives to  
J Lunderhauer & Co a Lien and Mortgage, as Security for  
advances, upon all timber as fast as gotten out, or sawn  
whenever it may be and does hereby authorize J Lunderhauer  
& Co or their agents, in case of any accident to the said M  
& Stokes, or whenever they may think it necessary for their  
Security, to take possession of and draw said timber, whenever  
it may be & get it to market, leaving the final settlement
