I know all men by these presents that Henry Bray of Santa Rosa County & State of Florida, in the consideration of the sum of five Dollars to me paid by Levi Brown of said County & State the receipt whereof is duly acknowledged, have resigned, released & forever quit Claimed & by these presents do resign release & forever quit Claim unto the said Levi Brown & his heirs all the estate, right, title, interest, use profit, Claim & demand whatsoever at law & in Equity, which I the said Henry have, of, in, to or out of, all & singular, a Certain tract or parcel of land lying in said County & State & known and described as follows - To wit, Beginning at a point on the North side of Peterss Basin. Twenty one (21) Chains and Twenty three (23) Links. West of the East line of Tract one (1) and Five (5) in section number two (2) Township one of Range Twenty Eight (28) Thence running due North Twelve hundred and Fifty three (1253) feet. Thence due West. Four hundred & Seventeen Feet & Eight inches (417 ft 8 in). Thence due south to Peterss Basin, amounting two acres (2) wide on said Basin, and running north six (6) acres deep, Containing Twelve (12) Acres, together with all and singular the privileges & appurtenances therunto belonging so that neither I, the said Henry Bray - my heirs or assigns or any other person or persons in trust for me or them or in way - in their name or names or in the name right or stead of any of them shall or will, Can or may, by any means or means whatsoever, hereafter have Claim Challenge or demand any right title or interest property Claim or demand, of in to or out of the said tract or parcel of land with the privileges and appurtenances therunto belonging or any of them or any part thereof. But that I the said Henry Bray my heirs and assigns & Every of them, from all estate, right title, interest property, Claim & demand of in to or out of the said tract, or parcel of land with the privileges & appurtenances therunto belonging, or any of them or any part thereof are, is, & shall be by these presents forever excluded & barred.
