

aforsaid, has agreed to furnish the supplies necessary for the completion of said Schooner and whereas, at the said party an advance of money from the said Frank Johnson in the payment for the supplies and necessaries so advanced by him the said Johnson his heirs and assigns by these presents that James Edgar of the State and County of said for and in consideration of the sum of five Dollars to me in hand paid by the said Frank Johnson (the receipt whereof is hereby acknowledged) have given granted bargained sold and conveyed, sold by these presents do give grant bargain sell and convey unto the said Frank Johnson his heirs and assigns all the hull masts spars rigging and furniture of the said Schooner, to have and to hold unto him the said Frank Johnson, and to his heirs and assigns forever, and further for the consideration of said party and for the better security to the said Frank Johnson, payment do hereby make create and deliver unto the said Frank Johnson, his heirs and assigns a Statutory Lien upon the Hull masts, spars, rigging and furniture of the said Schooner, both as she now is and as she shall be when completed by means of said advances, and further agree that after the completion of said Schooner (which shall be as soon as practicable) she shall be under the control of the said Frank Johnson his heirs and assigns and shall be used by him or them in lightening wood from Escambia Bay in said County to Pensacola in Escambia County Florida to aid in payment for said advances and when the said Schooner is not thus engaged in the service of the said Frank Johnson his heirs and assigns she shall be constantly crewed shall be paid to the said Frank Johnson for said advances and if the said Frank Johnson his heirs and assigns the full amount for all said advances as made by him within twelve months from the date hereof, and when said payment are made within the times last above written then this instrument of writing to be cancelled and void, else to remain in full force and effect
