granted bargained & sold and by these presents do grant bargain sell
and convey unto the said Sarah Greene her heirs and assigns forever
the following parcel of land lying in said County and State known and
described as follows to wit Part of Lot No (12) two of Section Number two (2)
Township Number one (1) North of Range twenty Eight West Commencing
at the North West Corner of said Lot running west on the Township line five
hundred and seventy one (571) feet to the road thence south with the meander
