 September in the year of our Lord one thousand  
 eight hundred & fifty six between William  
 McKain Constable of the first District for the County aforesaid of the  
 one part and William W Harrison of the County and State  
 aforesaid of the other part. Witness that whereas the said William  
 McKain Constable as aforesaid did lately seize and lay upon  
 a Certain Town lot or piece of ground situate lying and being  
 in the Town of Milton and County aforesaid known and distinguished  
 as Lot number 7 seven on Block No (32) thirty two on the plan  
 of said Town containing seventy three feet & six inches (73-6) front  
 on Adams Street one way by one hundred and fifty seven feet  
 and six inches in depth, or the other way as the property of A Janet  
 Kavanough by virtue of a writ of Fieri Facias issued by J. J. Allen  
 Jernigan a Justice of said District and County aforesaid in favor  
 of E. W. Kelly against said A Janet Kavanough, and after  
 publicly advertising said Town lot agreeably to law did put up  
 and expose the same to sale at public Auction on the first  
 on the first Monday in September instant at the door of the  
 Court House at Milton in said County within the legal  
 hours of sale when said Town lot was knocked off to said  
 William W Harrison at and for the sum of fifty Dollars he  
 being the highest and best bidder, now for and in consideration  
 of the said sum of fifty Dollars in hand paid to him the said  
 William McKain Constable, at and before the sealing and delivery  
 of these presents the receipt whereof is hereby acknowledged, the said  
 William McKain Constable as aforesaid, hath granted bargained  
 sold conveyed and confirmed and by these presents doth  
 grant bargain sell convey and confirm unto the said  
 William W Harrison his heirs and assigns all the right title and  
 interest of the said A Janet Kavanough in said Town lot of which  
 said A Janet Kavanough was seized and possessed in and to the  
 same with all the rights members and appurtenances thereto  
 belonging or in any wise appertaining to his and their own proper  
 use benefit and behoof forever in fee simple.
