This Deed of Conveyance made and entered into this Twelfth day of August in the year of our Lord one thousand eight hundred and Seventy three between John D Campbell, Daniel A Campbell, Malcolm A Campbell, Margaret C Mims formerly Margaret C Campbell and Sarah A Campbell heirs at law & children of Christian Campbell late of the County of Santa Rosa & State of Florida, deceased, and David M. Mims husband of said Margaret C who joins his said wife of the first part and Jane A Campbell wife of Charles C Campbell of the said County and State, of the second part - Witnesseth that whereas the said deceased in her life time and at her death was possessed in fee simple as of her own right and property the premises a lot of land hereinafter to be particularly mentioned and described, and while living and before her death, her death received of and from the said party of the second part two hundred and forty Dollars for the said premises a lot hereinafter to be particularly mentioned and described and agreed to make & execute a Deed of Conveyance for the same yet departed this life without having done so and the heirs aforesaid wishing to carry out in good faith the obligation and agreement of the said matter the said second the said David M. Mims joining his said wife in so doing, therefore the said party of the first part for and in consideration of the premises and the two hundred and forty Dollars paid to the said deceased in her life time by the said party of the second part the receipt whereof is hereby acknowledged and confessed, have granted conveyed and confirmed unto the said party of the second part all of their or either of their right, title interest claim as heirs at law & children of the said deceased of in and to the following described lot or parcel of Ground situate lying and being in the town of Milton County and State aforesaid known and distinguished as lot number (5) Five containing one square acre of Ground which was laid off by John C. McArthur Surveyor on the North half of Lot number (3) three of the 3rd section number (3) three in Township one north of Range twenty Eight West in the Tallahassee District of lands of the United States of America. It being conditioned that the said Jane C Campbell as aforesaid shall by these presents later and receive the absolutely and in fee simple as her separate and independent & distinct property in the same manner as she might do were she a female sole with full powers to dispose of the same by will or by joining her husband in the execution
