L. and A. 2 also one Cart now of the said Asa Paulk fails to pay or cause to be paid the money in said note, that on the first mentioned day of December next then the said Richard Fortune shall have power to seize upon and sell to the highest bidder giving at least ten days notice of the time and place of such sale the proceeds of day to be paid to the Asa Paulk now of the said Asa Paulk shall pay or cause to be paid the money mentioned in said note by the time it falls due then these obligations to be void otherwise to remain in full force and virtue this 23<sup>rd</sup> day of January 1881
