Santa Rosa County } in the year of Our Lord Eighteen hundred and
Eighty three between Wm J Johnson Sheriff of the
County aforesaid of the one part and Francis Jernigan and Samuel
Rushing of the same place of the other part Witnesseth that whereas
the said Wm J Johnson Sheriff as aforesaid did lately seize and
levy upon a certain lot of land situate lying and being in the
County and state aforesaid known and distinguished as Lot number
one (1) in Block Thirty by i. Town of Milton and County aforesaid
as the property of Wm H Potter by virtue of a writ of fieri facias issued
out of the Circuit Court of said County in favor of the State of Florida
against said Wm H Potter and after publicly advertising said Lot
of Land as the law directs did put up and expose the same to sale
at public outcry on the first Monday in June ad 1883 at the
door of the Court House at the Town of Milton in said County

Rushing at and before the sealing and delivery of these presents
the receipt whereof is hereby acknowledged the said Wm J Johnson
Sheriff as aforesaid hath granted bargained and sold and by these
presents doth grant bargain and sell unto the said Francis
Jernigan Samuel Rushing their heirs Executors administrators
and assigns all the right title and interest of the said Wm H Potter
in and to said Lot of Land of which said Wm H Potter was seized
and possessed in and to the same with all the rights members
and appurtenances thereto belonging or in any wise appertaining
to his and their own proper use benefit and behoof forever
in fee simple
