State of Florida This Indenture made this 24th day of August
Anno Domini 1883 in the year of Our Lord Eighteen and Eighty
Three between Wm J Johnson Sheriff of the County
of Santa Rosa County Florida aforesaid of the one part and Francis Jernigan and Samuel Rushing
of the same place of the other part witnesseth that whereas the said
Wm J Johnson Sheriff aforesaid did lately buy and buy upon a
certain lot of land situated lying and being in the County and
state aforesaid known and distinguished Lot Number 44 (6) in
Block Number Thirty-four (34) Thirty feet (30) by one hundred feet
(100) in depth the same being the south part of said Lot Number 44
(6) in the Town of Milton and County aforesaid as the property of
William H Potter by virtue of a Writ of Sale issued out of
the Circuit Court of said County in favor of the state of Florida against
said William H Potter and after publicly advertising said lot
of land as the law directs did put up and expose the same to sale
at public outcry on the first Monday in August AD 1883 at the
Door of the Court House at the Town of Milton in said County
within the legal hours of sale where said lot of land was knocked
off to the said Francis Jernigan and Samuel Rushing et al and
for the sum of thirty three Dollars and twenty five Cents (\$33.25)
they the said Francis Jernigan and Samuel Rushing being
the highest and best bidder: Now for and in consideration
of the said sum of Thirty three Dollars and twenty five Cents (\$33.25)
to him the said Wm J Johnson Sheriff aforesaid by the said
Francis Jernigan and Samuel Rushing et al and before the sealing
and delivery of these presents the receipt where is hereby acknowledged
the said Wm J Johnson Sheriff aforesaid hath granted bargained
and sold and by these presents doth grant bargain and sell unto
the said Francis Jernigan and Samuel Rushing their heirs executors
Administrators and assigns all the rights titles and interest of the
said William H Potter in and to said lot of land of which said
William H Potter was seized and possessed of in and to the same
with all the rights members and appurtenances thereto belonging
or in anywise appertaining to his and them own proper use
benefit and behoif for ever in fee simple.
