State of Florida, know all men by these presents that I C. D. Meigs
 County of Santa Rosa } of Malton County State of Florida for and in Consideration
 of Two Thousand (\$2000.00) Dollars loaned and advanced
 to my by Henry Davis of Santa Rosa County Florida in order to
 enable me to pay expenses there incurred by way of the hauling
 & putting in of Logs and that I may hereafter incur in the
 business of logging in which I am now engaged I do hereby
 give unto said Davis a Lien upon all logs that I now own
 & claim or that I may hereafter own & claim until a final
 clearing up of logs is made by me at the mouth of Yellow River
 Florida in the County of Santa Rosa said logs being all the logs
 now owned & claimed by me and hauled there to wit with
 a bar head & triangle cuts all logs hauled this to wit the
 letter A chopped in the logs and also all other logs in whatever
 head whatever or unheaded owned & claimed by me or any
 a drive of logs that is now below the fork of Yellow & Shoal River
 and known as the Tom Hainote Drive. The above logs upon
 which said Lien is given it is further considered and they
 are described as being all logs that I may own or claim
 outside of logs procured for the fulfillment of a Contract existing
 between said Davis & myself and known as the Simpson & C
 Contract & specified by said Davis & myself sometime in the
 month of Nov or 1885 said Tom Hainote drive already mentioned
 above except. Now the above Lien is given to secure the
 said Davis in the payment of said loan or advance mentioned
 and I also in consideration of said loan authorize and agree
 to give & permit said Davis to receive said Logs at the mouth
 of Yellow River for the purpose of chipping of the same by
 sale and the said Davis agrees to receive & sell the same
 and it is agreed and thereby authorize said Davis to repay
 himself the amount of said Loan To wit (\$2000.00) and to
 retain as Compensation for his services the sum of ten
 per cent (10%) on the entire amount of all logs and the
 remainder from the proceeds of the sale of said Logs the said
 Davis to pay over to me
