Choffin & Co are indebted to the Copartnership firm of Green Randolph and Company of Liverpool England of which said Copartnership firm the said George B. Lewis is a member on the sum of thirty five thousand (\$35,000⁰⁰) dollars, which the said James A. Choffin Francis Bryan and W. S. Keyser Copartners as aforesaid has promised and agreed to pay to the said George B. Lewis as follows to wit Two thousand Five hundred (\$2,500⁰⁰) Dollars with interest thereon at the rate of six per cent per annum one year from the date hereof; Seven thousand Five hundred (\$7,500⁰⁰) Dollars with interest thereon at the rate of six per cent per annum. Two years
