to whom these presents shall come bearing  
 Whereas at a sale of lands by H.S. Cleghorn Tax Collector of the Corporation  
 of the Town of Milton in the County of Santa Rosa State of Florida at Public  
 Auction at Milton in the said County of Santa Rosa on the 30 day of  
 December in the year of our Lord one thousand eight hundred and  
 Eighty Eight for the nonpayment of Taxes Levied and Assessed  
 thereon for the years one thousand eight hundred and Eighty  
 six and seven and which remained unpaid on the day of such  
 sale together with the costs and charges of due therewith the  
 following piece or parcel was sold to Joseph Ollinger who was  
 the best bidder therefor for the sum of Four Dollars, Two  
 Cents and Eight (8) in Block Thirty seven (37) in the Town  
 of Milton Santa Rosa County State of Florida and known as the  
 Mrs Lewis property which such sum covers the whole amount  
 of Taxes due and unpaid on said piece or parcel of land for the  
 years aforesaid together with the interest and cost due
