 bargain sell and convey unto said Mary L Collins all the
 following tracts of land situate in the County of Santa Rosa
 State of Florida and described as follows to-wit: The
 South West Cor of the North East Cor and the North West Cor of
 the South East Cor of section twenty Six Township two
 North of Range twenty Eight west (SW 1/4 NE 1/4 NW 1/4 SW 1/4 Sec
 26 T 2 N R 28 W) Containing Eighty ²/₁₀₀ (80%) acres more or
 less To have and to hold unto the said Mary L Collins heirs
 executors and assigns forever Now therefore in
 consideration of the premises the said Pensacola & Atlantic
 Rail Road Company hereby warrant and defend the title
 in and to the said aforegranted premises to the said
 Mary L Collins in fee Simple forever
