nine <sup>00</sup>/<sub>100</sub> (\$299<sup>00</sup>/<sub>100</sub>) Dollars paid and secured to be paid by  
William Judge to the Pensacola & Atlantic Rail Road Company  
a Corporation chartered by the State of Florida the said  
whereof is truly acknowledged the said Pensacola & Atlantic  
Rail Road Company has granted bargain and sold and  
by these presents does grant bargain sell and convey  
unto said William Judge all the following tracts or parcels  
of land situated in the County of Santa Rosa State of Florida  
and described as follows to wit: The North half of  
the North East quarter of Section fifteen (15) in Township  
Three (3) North of Range Twenty six (26) West and the  
North East quarter the East half of the North West quarter  
the North half of the South East quarter the South West  
quarter of the South East quarter and the South West  
quarter of Section (7) in Township two (2) North of Range  
Twenty Seven (27) West - Containing Five hundred  
and ninety nine <sup>00</sup>/<sub>100</sub> (\$599<sup>00</sup>/<sub>100</sub>) Acres - more or less.

It is to have and to hold unto the said William Judge - his  
Executors and assigns forever. Now therefore in  
consideration of the premises the said Pensacola & Atlantic  
Rail Road Company hereby warrants and defends the title
