To all whom these presents shall come touching  
 Whereas at a sale of Lands by W. J. Williams Tax Collector  
 of the County of Santa Rosa at Public Auction at Milton  
 in the said County of Santa Rosa on the 3 day of June in the  
 year of our Lord one thousand Eight hundred and 89 for the  
 nonpay ment of Taxes Levied and assessed thereon for the  
 year one thousand Eight hundred and Eighty Eight and  
 which remained unpaid on the day of such sale together  
 with the Costs and Charges due thereon with the following  
 described piece or parcel was sold to J. A. Chaffin & Co  
 who was the best bidder therefor for the sum of Two  
 Dollars and thirty five Cents for with East half of  
 Sec 12 Township 3 North of Range 29 West containing  
 320 Acres more or less - which such sum was  
 the total whole amount of Taxes due and unpaid on  
 said tract of land for the years aforesaid together with  
 the interest and Costs due thereon and the Charges  
 of such sale and has been paid by the said J. A. Chaffin  
 & Co W. J. Williams Tax Collector aforesaid
