This Indenture made and entered into this the 2 day of January in the year of our Lord one thousand eight hundred and ninety three (93) by and between George W. With and William E. With of the County of Santa Rosa and State of Florida parties of the first part and the Farmers Savings and Building and Loan Association of Nashville Tennessee (a corporation duly and legally organized under the laws of the State of Tennessee) party of the second part; witnesseth, that the said party of the first part for and in consideration of the sum of One Dollar in hand paid by the said party of the second part, and the other considerations hereinafter mentioned and fully set forth, have granted bargain and sold and by their presents do grant bargain sell convey and confirm unto the party of the second part and unto its Successor and assigns forever all of the following described tract or parcel of land, lying and being situate in the County of Santa Rosa and State of Florida to-wit: A certain tract of land lying in said County and State aforesaid and described as follows: The NE 1/4 of SE 1/4 Sec 30 Tp 2 N R 28 W. excepting there (3) acres in the corner of said lands also excepting the following described land sold by the said Geo. W. & W. E. With to Francis J. Jorgensen by deed dated Dec 7th 1891 beginning at the SE corner of the SE 1/4 of SE 1/4 Sec 30 Tp 2 N R 28 W running North on the section line 0¹² chains, thence N 74¹⁰ W 21¹² chains; thence South 7¹² chains, thence 20.00 chains to place of beginning, containing 7.00 acres. To have and to hold the same, with all and singular the rights, hereditaments and appurtenances thereto belonging or in anywise appertaining thereto unto the said party of the second part and its Successor forever, And the said parties of the first part do hereby covenant and agree with the said party of the second part that they are lawfully seized of said premises, that they have a good right to convey the same and that the same is never encumbered.

On the 8th day of January 1893 a mortgage deed was executed by Geo. W. With and William E. With to the Farmers Savings and Loan Association of Nashville Tennessee for the sum of \$10,000.00 one thousand dollars, said deed was registered in the Register's Office of Santa Rosa County Florida on the 10th day of January 1893 and it was referred to by the Farmers Savings and Loan Association in their report to the Board of Directors of the Farmers Savings and Loan Association of Nashville Tennessee on the 10th day of January 1893.

This is the Farmers Savings and Loan Association of Nashville Tennessee and it is the policy of the Board of Directors of the Farmers Savings and Loan Association of Nashville Tennessee to release Geo. W. With and William E. With from the mortgage deed executed by them on the 8th day of January 1893.
