Santo Rosa County } that we O. A. Thompson, Mary W  
Rounta and John Rounta her husband  
Ella B. Crony and J. B. Crony her husband, and H. W. Thompson  
and M. Anna Thompson his wife, all of Santo Rosa County  
Florida, and Sallie M. Walter and W. W. Walter  
her husband of Montgomery, Alabama and Nancy C.  
Keel of Texas, heirs of Benj. W. Thompson deceased  
for and in consideration of One Dollar to us in hand  
paid by Sarah L. Bushnell of Saybrook, Connecticut, the  
receipt whereof is hereby acknowledged and conveyed  
have granted, bargained and sold and by these presents  
do grant, bargain, sell and convey unto the said  
Sarah L. Bushnell her heirs and assigns forever  
all our right title and interest in and to the  
following real estate situate lying and being in the  
County of Santo Rosa State of Florida to-wit: Being a part  
of the tract known as the Arcadia Place in Section  
fourteen Township one North of Range Twenty Eight  
West County Beginning at the North East Corner of Sarah  
L. Bushnell's land in said Section, Township and Range  
declared to be by the heirs of Benj. W. Thompson, deceased, by deed  
of conveyance dated Twenty sixth day of July 1887 - and  
draining west one hundred and ninety seven feet  
thence running North Four hundred feet, thence running  
East Two hundred and thirty five feet, thence running  
South Four hundred and thirty five feet to the place  
of beginning, and bounded as follows on the North and  
East by land of the Benj. W. Thompson Estate, and on the  
South and West by land owned by Sarah L. Bushnell  
described in said deed of conveyance, dated July 26<sup>th</sup> 1887.  
Said piece of land hereby conveyed contains two and 7/8  
acres more or less. Also a piece of land in said  
Section Township and Range beginning at the North East  
Corner of land belonging to Mrs. S. A. Simpson and  
running North twenty five feet, thence running East  
one hundred and fifty feet, thence running South Twenty  
five feet, thence running West one hundred and fifty feet  
to place of beginning and bounded as follows: on the North by  
the road separating it from land belonging to Estate of  
Benj. W. Thompson on the East by land conveyed to Sarah L. Bush-  
nell by former deed on the South by land of Sarah L. Bushnell, and  
on the West by land of Mrs. S. A. Simpson. To have and to  
said described for parts, together with all and singular  
the tenements, hereditaments and appurtenances thereto  
belonging or in any wise appertaining unto
