Know all men by these presents that whereas
 the United States District Court for the Northern District
 of Florida in a cause wherein William Criglar individually
 and as a member of the firm of Criglar, Batchelder & Pooley,
 bankrupt, on the 2 day of December A.D. 1871 rendered a
