(Note: The Homestead is so hard to copy. It is from a stake in the prairie to a 14 inch Post Oak to middle of Fish Creek and to a Pecan tree 24 inches in dismeter and on and on - I have been there. This is last piece of land she sold. /s/ C. C.)

Miss Mattie Lake remembers her mother telling that Maj. Whitaker took an ox wagon and some slaves when he returned to Ga. His long delayed return, Rebecca's fears and grief - almost losing hope after several months - he brought back a walnut bookcase "which some of the Stewards have" and books.

Miss Mattie says he was a contemporary and friend of Sam Houston, Edward Burleson, Rufus Burleson and R. E. B. Baylor.

James M. farmed in Tennessee. 1850 be came to Rusk Co, Tex and 1856 to Smith Co - living in Tyler for many years. He taught school Ala, S C, Tenn, Miss & Texas.

He married Elizabeth S. Edwards. Born Dec. 10, 1823 in Troup Co, Ga, Died after 1889. Her father, Asa Edwards, was born 1798 Ga. In a letter from Ellen Whitaker she says her grandfather had been to Tyler and had gone--here's her words to her cousin Mary Worth Whitaker.

"Grandpa Edwards was at Fairfield the last of last May (written Sept. 19, 1864) to lend his money. He has been to see us since. He said if he had known you were living near Fairfield he would have gone to see you, but he did not know that you were not still living in Falls County."
